County School Boards. Under the present school law the terms of one-third of all the School Commissioners in the State expire biennially. Not until Governor Lowndes had been in office two years did he have an opportunity to put the Republicans in the maority in the school boards of the counties. Now the boards will remain in the hands of the Republicans for two more years. The terms of one-third of the members will expire this winter, but they are those who were appointed by Governor Brown in 1894 and, except in a few instances, they are Democrats. If therefore, Governor Smith appoints Democrats they will simply take the place of Democrats who will retire. The hold-over members are nearly all Repub licans.
