The Treasurer-elect, James T. Clark, holds a different view, and contends that he must qualify and enter upon his duties within 30 days after receipt of his commission at the clerk's office here. If this view is correct then Howard county may have two county Treasurers for about six months-from December of this

year until June of next year. It is clear now that the law creating a treasurer for Howard county needs amending, as the present situation of affairs was not contemplated or, rather, was an oversight.

American Enterprise Moving to the Front. Colony at Neuvetis for Development of the Coutry, La Gloria, Cuba,

Nov. 2, 1899.

We arrived here yesterday at 10 o'clock A. M. Don't know where to begin. Well, I must make a short sentence letter. Will begin at Nuevetis. The first step on land where I planted my foot was in the mud. The next that attracted my attention

was the rich verdure. Every plant seemed to be feasting on rich food. Nuevetis is old and rugged, but might be made a beautiful city. The harbor is lovely. We stayed there one day. Was just one week lacking one and a half hours from Eustis, (Flordia.) We had a very sick voyage all the way. From Nuevetis ten of us took a sloop to La Gloria; was twenty-two hours on the way; had no wind. Seven of us were the first stockholder emigrants that ever landed at La Gloria. Don't forget it. It was a doleful landing. A great storm and flood had proceeded us and for three miles back, the low lands were flooded. All the flat country is overflowed.
