Franchise Granted for an Electric Railway.

Application was made on Tuesday to the Baltimore County Commissioners, by Chas. G. Hill, Fred P. Ross and John G. Harlan, representing the Patapsco and Annapolis Electric Railway Company, for permission to construct an electric railway in the First district of Baltimore county, along the Old Frederick Road, beginning at a point on said road, now called Edmondson Avenue, where the railroad tracks of the United Railways and Electric Company of Baltimore, and the tracks of the Old Frederick Road, begin to run together on the south thereof, and running thence westerly along the Old Frederick Road to the intersection of the road with the Johns Creek Road, and running thence along the Johns Creek Road northwesterly to the lands of the Washington and Baltimore Railway Company, known as the Patapsco Park.

The commissioners granted the franchise for a line of five miles in length, and will cost \$150,000. The building of the road is required to be completed within twelve months. The road will be owned by the Patapsco and Annapolis Electric Railway Company, and will be operated by the same.
