

THE BATTLE OF FORT HENRY.

Official Report of Flag-Officer Porter. HEADQUARTERS DEPARTMENT OF THE MISSOURI, St. Louis, Feb. 20, 1862.

My Office A. H. Foster, Cairo, Ill., Feb. 7.—I have the honor to report that on the 6th inst., at 12 o'clock, P. M., I made an attack on Fort Henry, on the Tennessee river, with the iron-clad gunboats Cincinnati, Commodore Porter, Carondelet, Commanding Walker, and St. Louis, Lieutenant-Commanding Phelps, also taking with me the three old gunboats, Comstock, Lieutenant-Commanding Phelps, the Tyler, Lieutenant-Commanding Green, and the Lexington, Lieutenant-Commanding Phelps, which took position astern, and in shore of the armed boats, doing good execution there during the action, while the armed boats were placed in the first order of steaming, approaching the fort in a parallel.

The fire was opened at seventeen hundred yards distance, from the flag-ship, which was followed by the other gunboats and responded to by the fort. As we were within the range of the enemy's fire, we were obliged to keep on the steam, until we reached within six hundred yards of the Confederate batteries, the fire, both from the gunboats and fort, increased in rapidity and accuracy of range. At this moment the Commodore Porter was struck by a shot from the fort, which unfortunately received a shot in her boiler, which resulted in wounding by scalding of two nine officers and men, including Commodore Porter, as will be seen enclosed list of names. The shot then necessarily dropped out of action, entirely disabled and unable to take part in the fight in which she so gallantly participated until the sad catastrophe. CAPE RACE, Feb. 12.—The steamship Teutonia, which left Southampton on the morning of the 1st inst., passed this point at 6 o'clock this morning, and was intercepted by the new yacht of the Associated Press.

City Article of Jan. 31st, says Congress is now considering the bill to amend the act of March 6th. Numerous transactions took place at the discount market at 2 per cent.

Statement of Secretary Seward implying that the American Government held themselves responsible for the Confederates, to re-assert the right of the Confederates to be considered as the disquiet of the Federal Government, since it makes a further indefinite prospect of the ultimate amount of the debt.

It is believed that even if the war was wound up immediately, the debt of America would, at the rate of interest which must be paid, involve an annual charge on the revenue equal to more than the total required for the national debt of England.

A new Ministry has been formed in Holland. The Russians have been defeated in Circassia. Many wrecks are reported in the Black Sea. French troops are being rapidly despatched to Mexico.

The Herzegovina insurgents have re-entered the places from which Perish Pacha had driven them, without resistance.

The Teutonia reports passing through great quantities of ice. On the 11th, in latitude 49 deg. 30 min., longitude 32 deg. 30 min., passed the steamship Teutonia.
