-GOVERNOR GRASON'S MESSAGE. The governor gives a gloomy picture of the financial condition of the state, but suggests no mode of replenishing the public treasury. The subject is very properly referred to the wisdom of the legislature.

A considerable portion of the message is occupied by arguments against distributing the proceeds of public lands amongst the several states. It is supposed that the condition of the national treasury is such as not to admit the abstraction of the public land fund, without a resort to taxation or an increase of the tariff. The same necessity will arise should the lands be ceded, as is proposed, to the states in which they lie, for a more nominal consideration. An increase of the tariff, particularly on wines, silks, and other articles of luftury, will probably be deemed expedient under any circumstances; and, with such acrease, direct taxation could hardly be required. But, whatever may be the effect upon the national treasury, we think that the distribution as proposed in the land bill would be wise sent being strongly agitated in Washington.
