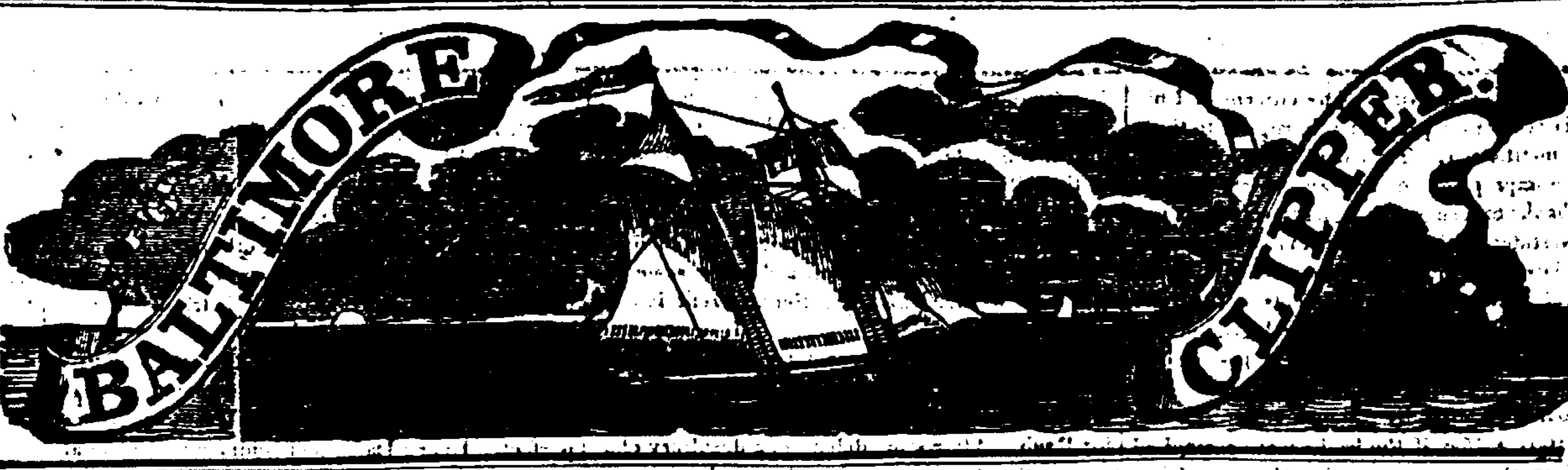

MARYLAND LEGISLATURE.

ANNAPOLIS, Feb. 10, 1841.

HOUSE OF DELEGATES. On motion of Mr. Coak, ordered that the committee on grievances and courts of justice inquire into the expediency and mode of providing such a repeal and modification of the ordinance of Baltimore City as will relieve captains and owners of vessels from the tax so imposed upon articles placed on board of vessels at the wharves in Baltimore.

Mr. Graves asked and obtained leave to bring in a bill to prevent the issue of circulation of small notes.

Mr. Pressman reported a bill supplementary to the act for the despatch of business in Baltimore County Court, passed December session 1839, chap. 161.

Mr. Graves made a favorable report upon the bill from the Senate to alter and amend the Constitution and form of Government so far as to provide for the election of County Clerks and Registers of Wills immediately by the people, which was made the order of the day for Tuesday next.

The House proceeded to consider the order of the day, being the bill from the Senate, entitled 'An act to incorporate the Trustees of the Poor of Baltimore City and County, and the amendments reported therefrom to a Committee on Corporations.'

The bill from the Senate to amend the Constitution so far as relates to the power of the Legislature to grant Lotteries, passed at the last session, was rejected.

Mr. Seidenstricker presented the petition of R. Leamon & Co. and others; asking that the dock in front of the State's property on Frederick street wharf may be deepened.

The bill to divorce Frances Smith was passed. The bill from the House to incorporate St. Vincent of Paul's Benevolent Association of Baltimore was passed.

The bill to amend the Constitution of the State was passed. A supplement to the bill of the present session incorporating the Baltimore and Potomac Steam Packet Company was passed.
