VERY IMPORTANT NEWS FROM EUROPE.—ARRIVAL OF THE COLUMBIA. Under our steamship head, on the first page, will be found most interesting intelligence, eight days later from Europe. We extract from the N. York Herald, for which we are especially indebted to the enterprising and indefatigable Wm. F. Harnden, esq. by whose express it was received in advance of the mail.

On our first page will be found a very excellent letter on Temperance, from a correspondent to his friend in this city. In our humble opinion it is a document, highly creditable to the writer and well worthy a perusal. We are indebted to Mr. Mitchell for the favor.

NATIONAL INTELLIGENCER. The readers of this valuable and ably conducted paper must feel themselves much indebted to the proprietors for the change which they have made in their mode of reporting the proceedings in Congress. But, we presume, that few are acquainted with the additional labor and expense which have been incurred in carrying into effect the new arrangements. Heretofore a mere congressional abstract was given, and the speeches of members were reserved to be reported at length. This necessarily required time, and the consequence was, that we had the speech long after the subject upon which it was delivered, had grown cold, or passed entirely from our recollection. Now the whole proceedings of both houses, including a sufficiently copious report of what was said, appear in the National Intelligencer on the morning after they have occurred. This is an important amendment, for which the proprietors of that paper deserve the thanks of the public, and particularly that portion of it attached to the newspaper press. To effect this change great additional night labor must be performed, and the reporting corps must be considerably increased. We can fully appreciate the sacrifices which have been made to add to the interest of the Intelligencer, and the incessant toil which those connected with the establishment have to undergo; and it excites our astonishment how so much can be performed within the given time. If "Sunday shine no holiday" to them, they must have a sad time.

We sincerely trust that the enterprising proprietors of the Intelligencer may receive an ample reward for their indefatigable exertions to increase the usefulness of their journal. It would be doing injustice to superior talents, industry and perseverance, were their paper to fail in receiving a bountiful patronage.

TWO WORTHIES. The American people, with a unanimity almost unparalleled, throwing aside all party feeling and political differences, have demanded that a liberal appropriation shall be made to the family of the deceased Patriot and late President, General W. H. Harrison, whose body yet lies in the public cemetery at Washington—and yet, when a bill was introduced into the House of Representatives on Thursday last for that purpose, the occasion was seized by Mr. Dean, an unworthy representative from Ohio, to speak in disrespectful terms of the deceased; and a Mr. Snyder, from Pennsylvania, endeavored to turn the subject into ridicule. The colleagues of Mr. Dean, and others, gave him a castigation, which, if he possess feeling, (which we doubt,) must have touched him to the quick; but poor Snyder appears to have been deemed too contemptible for notice, although he evidently sought notoriety. Men who could thus make war on the dead hero whom they would not dare to look in the eye whilst living, should be spurned with indignant contempt by all honorable men. Members may conscientiously entertain scruples as to the constitutional power of Congress to vote the appropriation; but the vile slanderers of the dead are unworthy seats in the House of Representatives; and they much mistake, if they think that any party will sustain them in their unjustifiable course.

THE GULF PIRATES CAPTURED. The New Orleans Picayune of the 9th inst. states that the tow boat Swan arrived from the Balize on that morning—she towed the Pilot schooner Argus, having on board Capt. de Patron and his crew of seven men found on board the piratical schooner and six other suspicious characters since arrested. Nugent, found on board the tow boat Tennessee, had a large bloody Bowie knife concealed on his person. They are all now in the Parish Prison. The Swan left the Pass at 9 o'clock on Tuesday morning—nothing certain was received at that time relative to those persons missing from on board the ship Charles.

Three Pilots and Mr. Henry Collins of that city, guarded the pirates up there.

PUFFING. The Organ men yesterday treated their readers to a column and a half of matter from its puffing department. It consists of sundry extracts from Western papers, announcing the receipt of the President's Message in the Organ extra, with various self-congratulatory comments by the proprietors of the Organ.—These they blazon forth as evidences of "Newspaper Enterprise;" and they would have it believed that they had expresses running to all parts of the Union. Now let us see how far they merit applause for their extraordinary enterprise. Their extras were printed, as those for other papers were, in Washington city. The U. S. express mail from Washington eastward, contained also a mail for the West which was transferred to the Frederick express car at the junction of the two roads. The great enterprise of the Organ men then, consisted simply in having a few extras directed to Western papers placed in the express mail in Washington, and here their labors, exertions and expenditures ceased. The same mail conveyed extras from the Intelligencer and Madisonian offices; and yet the Organ lays claim to marvellous enterprise, and would have it understood that their expresses outstripped the wind. We feel no disposition to detract in the least from their real merit, for we have no envious or malignant feeling to gratify—we therefore admit that their arrangement was judicious and proper. We can admire the hue of the snake, though it be a venomous reptile. But we will suggest an improvement to their arrangements for the West in future—it is, to obtain leave to send an agent with the car, and have the extras from other papers thrown from the mail. This would give them a monopoly in the line of extras, as they desire to have it in newspapers. And should any cotemporary still attempt fair and honorable competition, let the Organ men contrive means to pocket the letters of such competitor, and monopoly is secure.

There is one portion of the Organ article which, we confess, has excited our astonishment. It is that in which an appeal is made to the ladies.—If the statements of that print are to be believed, there are no ladies in Baltimore; for the term lady carries with it the idea of respectability of character; and is inapplicable to females who visit "assignment houses." We think that the Organ should at least have preceded its appeal to the ladies, with an apology for having slandered their reputations.

Whilst the Organ men were taking measures to send messages to Western papers, that they might obtain puffs in return, we were intent on being the first persons in this city to supply our customers with copies of that document, which we accomplished, in despite of the exertions of the "enterprising" puffers of the Organ.

THE EXCURSION TO ANNAPOLIS. The steamer Columbia, Capt. Gayther, in place of the Boston, as advertised, left our city on Thursday afternoon, taking with her about three hundred persons on the previously announced cotillion excursion to Annapolis. The evening, though about the time of starting threatened rain, proved to be fair and pleasant. We were one of the number on board, and can add our testimony to the fact that every thing went off satisfactorily. The prospect on the bay was delightful. When near North Point we counted distinctly fifty eight vessels, moving in different directions, some coming into, and others departing from, our port. So charming a scene we have not witnessed for some time. Here, doubtless, we should have begun to speculate upon the great machinery of commerce, had not our attention been diverted from the spectacle by the lively music of Murray's band, followed by dancing. Cotillion succeeded cotillion, and waltz followed waltz, until the time-honored city of Annapolis became visible, which was made about half past seven o'clock. We were hailed by a large number of the Annapolitans who had collected on the wharves, with great courtesy and kindness. After a sufficient time having elapsed for the purposes of supping, &c., (which was finely served up at the Maryland Hotel,) the bell rung and all hands were again on board, the steam up and the Columbia paddling her way homeward. We landed in Baltimore about 12 o'clock, all safe, taught, trig and trim. Mr. Ash and his partner who got up this trip deserve much credit—it was all O. K. The encouragement with which they have met, it is hoped, will induce them to give another, either to Annapolis or further down the bay.

MORE BANK FRAUDS. We think that some publisher could make a handsome sum, by collecting into one or a dozen volumes, as the case might require, all the accounts of Bank frauds and robberies, and the defalcations of public officers, agents, &c.—and we now furnish an additional item to go with the preceding mass. We presume that a few days will give us further particulars.

The Mobile Journal of the 11th instant says: "There are sundry rumors in town, of grave deceits of frauds in obtaining discounts at the Montgomery Branch of the State Bank. We have heard names given, and the amount fraudulently obtained on worthless or fictitious paper, is variously stated at \$150,000 to \$200,000. We refrain from mentioning any particulars, until we are sure of our accuracy."

THE BUNKER HILL MONUMENT. The Boston Transcript says, eight layers of stone have been added to the Bunker Hill Monument this season; each layer being two feet eight inches in thickness, making an additional height of twenty one feet four inches. The monument is now, consequently, upwards of one hundred feet in height, and it is rapidly increasing in altitude. We once feared that none of the present generation would live to see this monument completed. We no longer entertain such fears. Indeed, it is not risking much to predict, that the "top stone" will be laid on or before the 17th of June, 1843.

IMPOSITION UPON EMIGRANTS. The St. Johns N. B. News of the 7th inst. announces the arrival of the harbor, on the 26th ult. of a vessel named the Montreal Packet, commanded by Capt. Stuart, under circumstances of a very nefarious character. It appears that the Packet is owned by a Mr. Carson, and in the beginning of April last was cleared at the Dublin Custom House for New York, and sailed under that clearance, having on board 195 passengers bound to that port; many of them in the hope of rejoining friends and relatives from whom they had been long separated. These passengers had all paid from £4 to £4 10s. besides 4s. 6d. for a doctor, (although we understand there was none on board the vessel,) previously to leaving the harbor of Dublin.

The vessel, it seems, was kept out of her proper course on purpose by the Captain, and detained until the passengers, provisions had almost exhausted. He then proposed to make for Boston, to which those on board agreed. But instead of doing so he landed all hands at St. Johns harbor. Provisions were made, however, by the citizens for the cajoled sufferers, and steps taken to punish the aggressors.

NEW YORK CUSTOM HOUSE INVESTIGATION. The New York Herald has the following:—"Swartwout's deficiency has never exceeded \$400,000—that he has received permission to return home from the Government, and that when he returns home he will expose the knavery that made him a defaulter for \$1,250,000, by confusing his accounts. That Wm. M. Price is not a defaulter to the government at all—that his resignation of office was forced upon him by the intrigues of others—that when he went to Europe, his purpose was to return with Swartwout. That one Mr. Dayton, a respectable importer, has testified that he gave his check for \$25,000 by way of a compromise, to recover his goods from the public stores, amounting to \$400,000, including the usual duties. There are other round charges made against the officers of the customs, of secretly obstructing the foreign trade of New York at the instigation of a confederacy of manufacturers of other cities, which, as the evidence upon which they rest has not yet been made public, may or may not be true."

FROM FLORIDA. ST. AUGUSTINE, June 13. Capture and departure of Wild Cat.—Colonel Gates arrived yesterday from Fort Pierce, Indian River, in the Wm. Gaston, and informs us that 15 minutes before he arrived at Fort Pierce, Major Childs took the notorious Indian Wild Cat or Coscoochee, with 15 warriors and 3 negroes, in all 19, and after two days confinement they were shipped to New Orleans, in the schooner Walter M. Captain Thompson. He is as bold and independent as ever, and boasts of his having committed the horrid murders near the city some time since. This news was received by the citizens with three cheers.

COLONIZATION JOURNAL, vol. 1, No. 1, new series, conducted by James Hill, general agent of the Maryland State Colonization Society. This number is handsomely printed, and contains the report made by the President of the Society to the late State Convention, together with the entire proceedings of the Convention. The substance of this number of the journal has been heretofore published in the columns of the Clipper.

ACCIDENT ON THE MORRIS AND ESSEX RAIL ROAD. A loose piece of iron rail, called "a snake head," while the cars were in full speed, came in contact with the ground, forcing one end through the bottom of the car and through the thigh of a young man, a passenger. He is seriously ill from the accident. The unfortunate affair took place on Tuesday last.

RUINED FAILURE OF A BANK. Information was received in this city yesterday, stating that the Merchants and Mechanics Bank of Wheeling, Va. had failed. Its notes, we understand, were refused by the brokers. Some, however, did offer to purchase them at a very great discount. We shall probably have further and more definite particulars to-day.

THE amount of the suit instituted by the Bank of the United States against Mr. Biddle, its late President, is \$1,018,000, paid out during his administration, for which no vouchers can be found, of which sum more than four hundred thousand dollars, it is asserted, were paid to him for purposes unknown, upon the checks of the Cashier.

THE NATIONAL BANK. We learn that the Board of Trade of this city, adopted at its meeting held on Thursday evening, the memorial to Congress submitted by the committee to whom the subject was referred, asking the establishment of a National Bank.

SHIP STRUCK BY LIGHTNING. The foretop-gallant mast and fore top gallant yard of ship Mohawk, lying in Hampton Roads were shivered by lightning on Sunday afternoon last. The ship sustained no other injury.

OHIO RIVER. Extract of a letter from Wheeling, dated 16th inst.: "Our river continues low and a man might wade across any of the ripples between here and Pittsburg. In fact, it is scarcely knee deep."

MELANCHOLY. On Friday of last week, a dwelling house in the village of Kinderhook was burned down. It was occupied by a colored family. Five of its inmates, consisting of two grown persons and three children perished in the flames.

UNFORTUNATE. A deck hand on board the steamer Republican, on her way from St. Louis to Pittsburg, was accidentally shot by the discharge of a gun from one of the passengers. The deceased's name was Francis Willard.

HAY. The Germantown Telegraph says that the farmers in that quarter have commenced hay making in earnest. The crop generally is as good as in any ordinary season.

(Correspondence of the Baltimore Clipper.) WASHINGTON, June 18, 1841. This morning in the House, Mr. Adams offered a resolution setting forth that by the reconsideration of the vote adopting the rules, the standing committees were no longer in existence. After some remarks from Mr. A. it was decided that the position taken by him was untenable, and that the existence of those Committees was not affected by the recent action of the House.—Mr. Adams on his motion was then discharged from serving on the committee on Indian Affairs. The House then went into committee and took up the following bill.

A Bill for the relief of Mrs. Harrison, widow of the late President of the United States. It is enacted by the Senate and House of Representatives of the United States in Congress assembled, That the Secretary of the Treasury pay, out of any money in the Treasury, not otherwise appropriated, to Mrs. Harrison, widow of William Henry Harrison, late President of the United States, or in event of her death before payment, then to the legal representatives of the said William Henry Harrison, the sum of \$25,000.

Mr. Adams had moved to fill up the blank by inserting \$25,000. Mr. Gordon had moved to strike out \$25,000 and to insert \$6,520. Mr. Snyder's amendment relating to Mr. Ogle, being decided out of order, he moved to amend by striking out the sum proposed, and inserting "a gratuity of \$1,000 to be paid now to Mrs. Harrison, and ever after during her life a semi-annual payment of \$500."

Mr. Gilmer, of Va., thought that Congress had no power to make the appropriation in the bill. He thought the better way would be to lay the subject before the people of the U. S., so that, without distinction of party, the country at large might participate in the act of remuneration. In his opinion, generosity was a dangerous virtue in legislation.

Mr. Pope spoke briefly in favor of the bill. General Harrison was called to the Presidency by nineteen States out of the twenty-seven, and of course he was bound by every consideration to obey that call. He did so, but in so doing he incurred expenses which he was not able to bear; it was, therefore, the duty of Congress, inasmuch as the late President died before his salary could remunerate him, to be just and indemnify his family.

Mr. Biddle and others continued the debate. In the Senate, after the disposal of some preliminary business, the debate on the Report of the Secretary of the Treasury was resumed. Mr. Wright being entitled to the floor, resumed and concluded his remarks from yesterday, attacking the report as incorrect and sophistical. Mr. Woodbury replied to the remarks made by Mr. Evans on yesterday, and attempted to show that his charges against the report were substantiated by the report itself.

NEWS ABOUT TOWN. APOLOGY. We never wish to give offence, and are therefore always willing to apologise when we have unintentionally done wrong. It has been whispered in our ear, that our having designated a certain paper as the "Penitentiary Organ," is extremely offensive to some of the inmates of that state institution. They have no desire that additional odium shall be cast upon them. We assure them that we had no design to wound their feelings; but as the thing is christened, the name cannot be recalled.

ACCIDENT. A boy of about ten or eleven years of age, living in a house in Hanover street opposite the market, fell from the top of the garret stairway over the banisters to the landing place below, striking upon his head, injuring himself severely, though, we believe, not dangerously. When seen by our informant, some half hour after the occurrence, he was still delirious from the effect of the fall.
