FUNERAL OF GEN. MACOM. The funeral of this late distinguished General will take place to-day, in Washington, at 10 o'clock, A. M. The order of the procession will be found in another column.

PUBLIC LANDS. The bill introduced by the Hon. William Cost Johnson, of Maryland, for the distribution of the proceeds of the sales of the public lands among the several states, was called up on Friday last, when Mr. Johnson addressed the House in an able, satisfactory and convincing speech in favor of the measure. Had we room it would afford us pleasure to publish his address; for we think, that, after a careful examination of his facts and arguments, every man in Maryland open to conviction, would concur in the propriety of the measure recommended. Indeed, it appears to us most extraordinary that argument should be necessary with any citizen of Maryland, to shew the justice and expediency of the proposed distribution. The State is deeply involved in debt, and the people are subjected to heavy taxes.—The faith of the State is pledged for the debt, and it must be redeemed, or we be dishonored, to which we presume no one would consent. It cannot be denied that the public lands are common property, and that Maryland has her equitable interests in them. Shall we then permit these lands to be given to the states in which they lie at a nominal valuation, or have them sold as heretofore, receiving our distributive share of the proceeds? If we desire to have the present taxes continued, and perhaps increased, we will adopt the advice of those who oppose the distribution bill; but, if we would lessen our burthens and be finally relieved from them, we will not forego our just claim upon the public lands, and let them go to enrich the citizens of the new states. To abandon our right would, indeed, be the extreme of liberality. It would be double-refined folly, for which we should deserve to sweat and labor the balance of our lives.

We care not what politicians on either side may say on this subject. We do not look at it as politicians, but consider it as a matter of interest. The assessors are now engaged in their duties, and this fall the tax gatherers will pay their unwelcome visits. Who is there that would not rejoice if the amount to be paid could be reduced a fourth or a third? Not an individual. And yet when it is proposed to effect this, and probably a greater reduction, some men are so mad as to call upon the people to reject the offer, and to continue the present rate of taxes. We beg that the people will disconnect this subject from politics, and look at it with an eye to the justice, propriety and advantage of the measure alone. It is worthy of serious and deliberate consideration.

LECTURES OF DR. AIKIN ON CHEMISTRY. We publish, with great pleasure, the following proceedings of the ladies and gentlemen who attended the recent course of lectures on Chemistry, delivered by Professor Aikin. The science of Chemistry is a delightful and useful study; but as few persons have the leisure and the apparatus necessary to make themselves familiar with the subject, it is satisfactory to know that the lectures of professor Aikin, accompanied by experimental illustrations, afford all the information that is necessary for practical purposes. We are pleased to see that the ladies are turning their attention to this science; as they will find the time devoted to these lectures not only pleasantly but usefully employed.

At a meeting of the ladies and gentlemen composing and attending Prof. AIKIN'S summer course of Lectures on Chemistry, the following Resolutions were adopted, unanimously:
Resolved, That the class sincerely tender their warmest thanks to Prof. AIKIN, for the interesting and satisfactory Lectures delivered by him, and for the beautiful experiments performed during his summer course.
Resolved, That we are truly gratified to learn that Prof. AIKIN proposes giving a similar course the ensuing summer of '42; and we would furthermore most earnestly recommend to such as have not, or could avail themselves of the present course, to become members of his class, at the very commencement, and acquire a knowledge of one of the most beautiful and useful of the sciences, fully evinced as it has been by our very able and beloved Lecturer, in the use of the most complete and elegant Philosophical apparatus in the United States.
Resolved, That an attested copy of these Resolutions be presented to Prof. AIKIN, and also to the daily papers of the city, with the compliments of the ladies.

DREADFUL RESULT OF INTEMPERANCE. A most shocking scene, caused by intemperance, took place in Rochester on the 22d inst. It seems that a man named John Rawley, had been on a drunken frolic for about ten days; finally, he returned home bringing with him some arsenic. The Post states that while his wife was out of the room preparing breakfast, he went to a pail of water, where his wife found him drinking when she returned. She soon observed some white substance in the water; but thinking it was merely some magnesia, she drank some of the water, as did two of the children. She sickened immediately, but was soon relieved; and the children (one of eight, and the other about three years old) are in a fair way of recovery. This is another warning to those who are abandoned to the base and intemperate.

REMAINS OF GEN. HARRISON. On Saturday afternoon, between three and four o'clock, the mortal remains of the late President were brought into this city from Washington, in charge of the committee appointed to convey them to North Bend. From the depot they were transmitted to Barnum's Hotel, in a car guarded by eight U. S. Marines, and followed in solemn procession by the committee and a few of our venerable citizens, costumed in black, wearing appropriate badges of mourning. The body was placed in a basement room of the Hotel, fronting on Fayette street. This was deemed most prudent by the committee, as they wished to keep it in the coolest place possible. It may be proper to remark that the arrangements from the depot to the Hotel were entirely under the supervision of Mr. Barnum himself, it being desirous to avoid show and parade. The body is enclosed first in a leaden coffin, which is placed in a mahogany one and then in one of zinc, hermetically sealed.— This is also enclosed in a coffin of walnut, with chloride of lime filled in between it and the zinc, which is very substantially made, and air-tight. Covering the whole is a rich black silk velvet pall, trimmed with gold fringe and hung with gold tassels. When the body was exposed to the committee at Washington, a short time previous to its removal, it had undergone very little change. The features appeared as at death, except that the face was a little swollen.

On Saturday evening the U. S. Marines were relieved by the Independent Blues, who kept sentry by turns, pacing the pavement fronting where the remains were deposited, until one o'clock, when they were relieved by the Eotaw Infantry, who volunteered and kept guard until morning, when the National Guards took their place during the day. The First Light Division of Maryland Volunteers, under command of Brig. Gen. B. C. Howard, are ordered out, and will escort the remains from Barnum's Hotel to the Depot of the Susquehanna Railroad, whence they will be transported to York, Pa., thence to Columbia, thence by way of canal to Pittsburg, and thence down the river to North Bend. Some of our military companies intend going as far as Columbia, in which case no charge will be made by the Railroad Company either going or returning, which privilege has been liberally granted by the president and directors. For this generous act much praise is due them.

DIVISION ORDER. The First Light Division of Maryland Volunteers will parade on this (Monday) morning, to escort the body of Gen. Harrison, late President of the United States, to the cars in which it is to be transported to York. The line will be formed in Baltimore street, facing South, with the right resting on Calvert street, at 7 o'clock, precisely; as the hour of the departure of the cars is fixed, punctuality is indispensable. Other volunteer corps are respectfully invited to unite with the division.

EXTENSIVE CIRCULATION OF THE CLIPPER. We had practical evidence on Saturday last of the great benefit which results from the extensive circulation of our paper, and of "newspaper enterprise" when properly directed. Whilst some of our contemporaries were sound asleep on Friday night, our vigilant eyes were wide awake; and the consequence was, that on Saturday morning we announced the daring robbery of Midshipman G. D. Brown, and the commitment of E. Cook and W. Dennis as the suspected perpetrators of it. As the Clipper is taken every where, and read by every body, soon after its appearance, Mr. Wilson, living near Baltimore street bridge, repaired to the magistrate's office and gave information that two watches, one gold, the other silver, and fifty-one dollars, five ten dollar notes on a Bank in Wheeling, and a one dollar note, had come into his possession under the following circumstances: on Friday morning, as soon as the store was opened, two men entered and asked his mother, who was in the store at the time, for a pair of pumps—they purchased a pair, and offered in payment a ten dollar Wheeling note, which she declined changing. One of them drew from his pocket the two watches and some more notes, and remarked that they wished to leave those articles in her care, as they were strangers in the town, had got on a spree the night before, and were going on another that morning, and were fearful they might lose the property. Their request was peremptorily declined, but they insisted upon leaving the things, saying they would call in the course of the day for them; and finally settled the dispute by walking off and leaving the watches and money on the counter. Upon her son's learning from her what had passed, he communicated the fact to some of his neighbors, who advised him to wait awhile and see if they would return. About two o'clock they did return, asked for the watches and money, stating that they were about to leave town that afternoon, received them and left the store.

Near dusk one of them returned, took a paper out of his pocket, which he said contained the money, stating that they had been disappointed in getting away, and would not leave until the morning, and they would again leave the money with her for safe keeping. This proposition met with a positive refusal from Mrs. Wilson, when the gentleman settled the question by walking suddenly out, leaving the paper on the counter. Upon its being opened, fifty-one dollars, as above described, were found in it, and the two watches, which had not been mentioned or shown by the person leaving the paper.

We have before stated the manner of the arrest and commitment of the parties suspected of the robbery, but, if we except the affidavit of Mr. Brown, the loser, there was, at that time no evidence against them sufficient to lead to their indictment by the grand jury; and, had the publication not appeared in the Clipper the probability is, that the rogues would have been discharged on Saturday for want of evidence, and Mr.

Brown would have lost his watch and money.— Thus is seen the great benefit which arises from having the Clipper so generally distributed. We dislike puffing, otherwise we could blow a blast which would startle our sleeping neighbors, and frighten them into fits. But we are content to "do the State some service," without making a blowing horn of the business. We are glad that midshipman Brown has recovered his property, and that the rogues will be hauled over the coals, through our instrumentality. We can tell the light-fingered gentry that whenever the Clipper gives chase they might as well surrender at discretion for there is no chance of escape.

The facts above stated shew the advantages of advertising in our paper. But enough has been said. People have discretion, and know too well where their interest lies, to need direction.

HONOR TO WHOM HONOR IS DUE. Too much praise cannot be awarded to the diligence and activity of the officers by whom Dennis and Cook, those "nice young men" who robbed Midshipman Brown, were arrested and brought to justice. It will be remembered that the robbery was committed about one or two o'clock on Friday morning; warrants were placed in the hands of the officers late on the afternoon of that day; and in an almost incredibly short space of time, one was arrested by Mr. Charles Brown, assisted by citizen Cook; and the other by Mr. H. Chisholm, assisted by Mr. Hitzleberger, and both were conducted into the presence of A. H. Pennington, Esq. the magistrate, by whom they were committed, after a most thorough and able examination of all the circumstances.

SHOCKING DECAPITATION. The Norwich (Cl.) Courier says that Mr. John Armstrong, while detaching the freight cars from the locomotive on the railroad at that city on Tuesday last, was thrown upon the track and his head was instantly severed from his body by the whole train passing over him. Mr. Palmer, another brakeman, also fell under the train while endeavoring to rescue his friend, and one of his legs was crushed off just below the knee. A coroner's jury, after careful inquiry, absolved the conductors from all blame.

NEWS ABOUT TOWN.

DISGUSTING SCENE. Passing along Gay-st. on Saturday morning, we observed a female of rather respectable appearance, seated on one of the steps in front of the church, who, from her language and manner, appeared to be under the influence of liquor. About ten o'clock the same evening we saw a crowd gathered round some object on the pavement, near Baltimore street bridge. On making our way into the circle we discovered the same wretched woman, partially lying on the step of a door, where, apparently, she had fallen—a basket which, when we first saw her, contained some food, doubtless bestowed by the hand of charity, lay beside her with her bonnet in it, while the miserable being herself had sunk into a state of lethargy from which she could only be roused sufficiently to utter occasional moans. The sight was revolting to humanity. Drunkenness in man is incenseable—say, it is deeply debasing; but when a woman abandons herself to the control of this disgusting vice, so monstrous is the pollution that the mind sickens at the bare reflection of the fathomless abyss of degradation into which she has cast herself.

TWO EXTRA SPLENDID NUMBERS.—The *Lady's Book* and *Graham's Magazine*. We have been handed by Mr. N. Hickman the *Lady's Book* and *Graham's Magazine*, for July. They are decidedly the richest specimens we have seen. The engravings are of a very chaste and elegant order; two of each, besides a plate of the latest fashions, are to be found in the numbers before us. This is something extra. The contents are more than usually interesting. We commend them to the tasteful reader, and especially to the ladies. We are also indebted to Mr. Wm. N. Harrison, for a number of each of the above works, which he received since writing the above.

SUDDEN DEATH. While an individual, who had shipped on board of the schooner *Canora*, bound to Key West, was engaged in assisting to haul the vessel out from Spear's wharf, he was seized with spasms of so violent a character, that he expired in a few minutes, although medical aid was procured for him, as soon as he was attacked. His name was Joseph Alters, a native of the State of Maine, aged about 30 years. Wm. Rice, Esq., coroner, held an inquest over the body, and a verdict was returned according to the facts as above stated.

THE PHOENIX AND BUDGET. The July number of this excellent Baltimore monthly is upon our table. We have perused it carefully and with much interest. It is a work of merit, has a number of excellent correspondents, and displays both tact and talent in the editorial department. We are in favor of home productions. The prosperity of the Budget therefore is gratifying.

RAPE. We have been informed that a rape was committed on Saturday afternoon last, about two miles from this city, near the Reister-town road, on the person of a young and beautiful German girl, who resides on Pennsylvania Avenue. She had been in the habit of bringing in cows from pasture, and it was while on this duty that she was met by the negro. He has not yet been arrested.

REMON. It was rumored in this city yesterday, by passengers from N. York, that two men had been arrested in that city, on suspicion of being concerned in the robbery of the Frederick County Bank.

OBTAINING GOODS ON FALSE PRETEXTS. Jno. N. Cunningham was on Friday last, taken before Squire Pennington, on a charge of obtaining, upon false pretences, certain goods and household furniture, the property of Mrs. Bridget M. Kearney, his own mother. On the part of the defendant evidence was produced to shew that his mother had sold him the contents of the store, for fifty dollars, to be paid in twelve months, the mother, in the meantime, to board with the son. To prove this agreement a paper was produced purporting to be the copy of an original contract signed by Mrs. Kearney, in which she agreed to sell to her son the effects of her shop, for fifty dollars, giving him a credit of twelve months for the payment of the money, and which, according to the testimony of the witness who testified to this point, was drawn by him, (the witness,) and partially signed by Mrs. Kearney, when he finished the signature, and affixed the mark, under the impression that all the parties were satisfied with the arrangement. Some further evidence was produced on the part of the defendant to shew that Mrs. Kearney had been treated kind by his family, and had nothing to complain of.

Mrs. Kearney, the complainant, stated that she had partially signed the agreement, of which the paper produced in court was a copy, but that it was signed in consequence of threats made by her son. He had caused the original paper to be drawn up, and had come into the room back of the shop, and wanted her to sign it; upon declining, he said she would have to do it, or they would wait on her no longer. He then ordered the furniture to be taken out of that room, and carried up stairs, which was done; and he threatened to lock her up in the room and keep her there, without any one to wait on her, if she would not sign. Under the fear excited by these threats she agreed, and did partially sign, the balance of the name and the mark being completed by the person who drew up the paper. She remained with her son's family about ten days afterwards, when their conduct was so threatening and violent, as to compel her to go up stairs and remain there, (she being the legal occupier of the house, which she had kept for thirteen years,) since that period she had been compelled to sell one of her beds to obtain necessaries, had to cook for herself, and had been subjected to insults continually from her son and his family, whenever she left her room.

Upon a review of the testimony in the case, the Justice committed the traverser, in default of security, to answer the charge before the court.

UPSET OF A SAIL BOAT. We understand that a sail boat, in which five or six gentlemen were taking a pleasure excursion on Saturday afternoon, upset off the Lower Canton House, precipitating all hands into the river. Fortunately they managed to cling to the bottom of the boat until she righted, and gained the shore without further injury from the accident than a thorough wetting.

INCORRIGIBLE. Washington Demmit, whose confinement, for want of security to keep the peace, we noticed some days since; and who was, on Saturday morning, released from prison, was re-committed the same afternoon, and charged of again disturbing the peace of the state and threatening his neighbours.

FIRE. The alarm of fire on Friday night at eleven o'clock, was caused by the burning of a barn, the property of James Carroll, Esq., situated near the bridge over Gwynn's Falls, on the Washington turnpike. For the Baltimore Clipper: MESSRS. EDITORS: I have seen notices in several papers in regard to an order passed by the directors of the "Green Mount Cemetery," to have it closed on Sundays, save to lot-holders. My object in addressing you is, for the purpose of coinciding with the authors of several communications, and also to give you the feelings of a great number of ladies on the subject. They love to walk out a short distance from the city on Sunday afternoon, accompanied by a male friend. They love to sit in those "elysian bowers" of Green Mount so congenial to the taste of romantic lovers, or to recite over the deeds of bygone days, of "noble battles gloriously won," and victories over man as gloriously achieved—and where's the place so suitable:—None—none in the wide range of your far-extended city. There may the love-sick swain read the memorial of others placed in the same situation, or the broken-hearted widow mourn the loss of a beloved husband, or the ambitious young man may read on those marble tablets the history of many very many, who, by industry and perseverance, have achieved immortal honors.

Then, since this place is so well suited for the retreat of old and young, the rich and the poor, why not revoke their decree, and open the gates to respectable visitors?

What has made Mount Auburn and other places of the same cast so notorious? It is because they are open to the visits of the inhabitants of their respective places; and thus they receive that high praise and encomium which they so richly merit. Let the press of Baltimore come out and speak its sentiments candidly and boldly, and the object is achieved. VERNON. [We think that it might be well to admit visitors, other than lot-holders, to the Cemetery on the Sabbath, not precisely for the reasons assigned by our correspondent; but because it would offer an agreeable and healthy walk to the ladies. It would no doubt become a place of great resort, and, perhaps, the managers apprehend that there might be disorder among the concourse. To avoid this there should be rigid rules rigorously enforced; and no man under the influence of liquor should be permitted to enter the premises. The sacred character of the place should forbid all idleness; and no person of correct feeling or principle would be guilty of misconduct whilst within the limits of the Cemetery. If it could be opened to visitors on Sunday, and be preserved entirely free from disorder, it might be well—but of this the managers must be the best judges, and we presume that they have satisfactory reasons for the course they have adopted. We believe that they have the disposition to gratify the public as far as they can do so consistently with their own ideas of propriety.]
