## BRAZIL SAID TO BE THE REFUGE OF THE COTTON LORDS.

It is stated that "a good many Southern families are removing to Brazil in order to hold their slaves in peace." We find his announcement going the rounds of the newspapers, and it is so near "the universal fitness of things," considering the past and present—that without knowing the authority for the statement, we must needs believe it to be true.

As the planters of the Gulf States started out to make slavery, or a slave empire, extend to "Mexico and the isles of the sea," and thereafter, of course, with their known and progressive ambition, to embrace the whole western world, it is but natural now with the whole thing reversed, not only winning no new territory but losing what they already had, to turn to the next possible chance, and run for shelter in their districts to the only government in the western hemisphere which affiliated with their views, and which will recognize them and the "peculiar institution," those who may be a desirable acquisition.

Besides, if Mr. Russell of the London Times and Mr. Brown of Georgia, have set forth the facts correctly, in regard to their leaning towards monarchical government, they, in going to Brazil, follow out their proclivities with fidelity. In the attempt here to thoroughly revolutionize matters—to overturn an aristocratic or "monarchy," they have had a vast deal of trouble, and danger and loss; and as masters look now, if they persevere in their endeavor, they are likely to have still more.

Moving off to Brazil, however, will find a monopoly made all ready to their hand, and with it is but little more expensive and troublesome to get there, than it was in the olden time to move from South Carolina or Georgia, to Mississippi or Texas.

Even under the old condition of things, it was some hardship to "pull up stakes" for a new country, where through necessity, usage, or something else, there was no prospect of staying permanently. To make cotton, was the great purpose; and camping long enough, in a place, whether five, ten, or twenty years, to destroy the soil, they had the prospect of making another, and another more as circumstances might seem to compel.
