Washington, Dec. 11, 1864.

Sir.—Mr. Collier presented a petition from George W. Matis & Co., and said for a Bill, praying an alteration of the law relating to tobacco, so as to allow the same to be sold in packages of less than one pound.

Referred to the Committee on Post Roads.
