LETTER FROM WASHINGTON.

Correspondence of the Baltimore Clipper.

WASHINGTON, March 27, 1861.

The revelations from the insurgent capital, the declarations of Mr. Stephens, the testimony of General Lee, the protestations of Herschell V. Johnson, all go to confirm the public expectation that the rebellion is approaching its final catastrophe; and that, though Davis may desire to persist in the career which has brought desolation and ruin upon the South, neither the people nor the people are disposed to submit longer to a régime of arbitrary and privative in peace and war. They are, therefore, ready, nay, anxious, to negotiate for peace on the basis of obedience to the Constitution and laws of the Union.

While they know that the President of the United States will not, under any circumstances, recognize their so-called "Confederacy," or consent to treat with them on that title of "President of the Confederate States," they hope that he will agree to "negotiate" with their agents, or their emissaries, who appear in his presence, overbearing ambition, and vindictive cruelty to be the chief obstacle in their way; and it may not be long before the accumulated wrongs and resentments of a harassed and exasperated community may sweep him from their midst, if there is no other means to effect the measure of their misery.
