DEATH OF THE PRESIDENT.

WAR DEPARTMENT. WASHINGTON, April 15, 1865. Major General Dix, New York: ABRAHAM LINCOLN died this morning at twenty-two minutes after seven o'clock. EDWIN M. STANTON, Secretary of War.

FURTHER PARTICULARS.

WASHINGTON, April 15, 8 A. M.—President Lincoln is dead. He died this morning at 7.30.

THE LAST HOURS.

WASHINGTON, April 15.—The Star Extra just issued, has the following account of the last hours of the President's life. At 22 minutes past 7 o'clock, the President breathed his last, closing his eyes as if falling to sleep, while his countenance assumed an expression of perfect serenity.

THE ASSASSIN'S WORK COMPLETE.

There were no indications of pain, and it was not known that he had until the gradually decreasing respiration ceased altogether. Rev. Dr. Gurley, of the New York Avenue Presbyterian Church, immediately on its being ascertained that life was extinct, knelt at the bedside and offered prayer, which was responded to by all present.

DEATH OF THE PRESIDENT.

Dr. Gurley then proceeded to the front parlor, where Mr. Lincoln, Capt. Robert Lincoln, Mr. John Hay, the Private Secretary, and others, were waiting, where he again offered up prayer for the consolation of the family.

THE ASSASSIN'S WORK COMPLETE.

At six o'clock the pulse of the eminent sufferer perceptibly failed, and at half past six o'clock it was observed to be so feeble and the breathing labored, that at seven o'clock there were symptoms of immediate dissolution, and twenty two minutes past seven o'clock closed the scene!

THE ASSASSIN'S WORK COMPLETE.

Surrounding the death bed of the President were Secretary Stanton, Secretary Welles, Secretary Usher, Attorney General Speed, Postmaster General Dennison, Mr. H. Field, Assistant Secretary of the Treasury, General Halleck, Gen. Meigs, Senator Sumner, F. R. Anderson, of New York; General Todd, of Dakota; John Hay, private Secretary; Gov. Oglesby, of Illinois; Gen. Farnsworth, of Mass.; and Miss Kenny, Miss Harris, Captain Robert Lincoln, son of the President, and Drs. E. W. Abbott, R. H. Stone, C. D. Welch, and Dr. Secretary McCullough remained with the President until about 5 o'clock, and Chief Justice Chase, after several hours attendance during the night, returned again early this morning.

Senator Yates and Representative Farnsworth, of Illinois, being among the number admitted. The body is being embalmed, with a view to its removal to Illinois.

ADDITIONAL PARTICULARS.

Owing to the melancholy event the Superintendent of Police has caused places where liquor is sold to be closed during this day and night. Flags over the Departments and throughout the city are at half-mast. Scarcely any business is being transacted anywhere, except on private or pre-concert whatever, are dropping their premises with festoons of mourning. The bells are tolling, strong men weep in the streets.

ADDITIONAL PARTICULARS.

The grief is widespread and deep, and is in strange contrast to the joy so lately manifested over the recent military victories. This is indeed a day of gloom. Reports prevail that Mr. F. W. Seward is dead, but this is not true. Information was, however, obtained by direct inquiry at 11 o'clock, that his condition is considered critical. His head is horribly injured.

ADDITIONAL PARTICULARS.

Secretary Seward suffers intense pain. The gashes made upon his cheek and throat are frightful, but still he is not believed to be in immediate danger, nor in a worse state than his son Frederick.
