FROM NORTH CAROLINA. An important order has just been issued by Gen. Schofield. HEADQUARTERS U. S. ARMY, THE OCHO, BALTIMORE, APRIL 27.

General Order No. 31.—The Commanding General has the great satisfaction of announcing to the people of North Carolina, that hostilities within this State have definitely ceased. That for the war to be ended, and the peace which will soon be restored throughout the country.

It is now the duty of all to cultivate friendly relations with the people of the North Carolina, and to restore to the country the peace and good order which has been so long desired. It is confidently believed and expected that the troops of the army and the people of North Carolina will unite in hastening the day to accomplish this great end.

All good and peaceable citizens will be protected and treated with kindness. The troops will be quartered as best as possible to secure the interests of the United States Government and protect the people until a civil government can be established in harmony with the Constitution and laws of the United States.

It is now the duty of all to cultivate friendly relations with the people of the North Carolina, and to restore to the country the peace and good order which has been so long desired.
