OFFICERS ENTITLED TO RECEIVE CORRESPONDENCE FILED OFF

WASHINGTON, June 6.—Much misapprehension exists in regard to the application of the law which provides that certain officers of the Government may receive mail matter, on official business, free of postage. Especially do persons in the military service frequently address documents of importance to medical directors, chaplains, sutlers, and other parties, to whom the same cannot be delivered except upon the payment of the regular rates of postage. Such a practice is often resorted to, and hence this class of papers are constantly being sent to the dead letter office, necessarily causing much delay and embarrassment in regard to the disposal of them, as it is often difficult to find the owners.

THE 7-30 LOAN.

PHILADELPHIA, June 6.—The subscriptions to the 7-30 loan in all parts of the Union as follows: Jay Cooke amount to \$3,125,000. The largest Western amount was for \$100,000 from Chicago. The largest Eastern subscription was for \$1,500,000 from Steadman, Ewell & Co., New York; \$250,000 from Fisk & Hatch, of New York; \$200,000 from the First National Bank; and \$100,000 from the Ninth National Bank of New York; \$200,000 from the Second National Bank of Boston; \$50,000 from the First National Bank of St. Albans, Vermont; and \$50,000 from the First National Bank of Portland, Maine.
