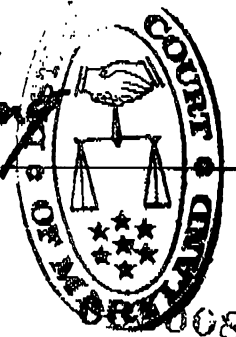

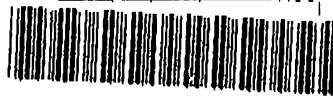

On Monday, March 27, 2006, Officer Warehime, #4791, responded to a call of a fraud in progress at SEARS Department store located at 6901 Security Boulevard, 21207. Upon arrival I met SEARS Loss Prevention Officer Dan Davies. LPO Davies stated that he had observed an unknown black female and unknown black male purchase 4 pairs of shoes, Sketcher Sport \$49.99, Reebok \$49.99, Giorgio Brutini \$44.99, Disney \$15.98, total value \$169.00 with a CHASE Bank U S A. credit card. LPO Davies stated that the unknown female had presented a South Carolina driver's license with the name of Deanna Cotton as identification and signed for the purchase. LPO Davies stated that he contacted CHASE Bank U S A. with a concern about the credit card. LPO Davies was advised the credit card had been reported stolen by the assigned holder of the card Deanna Cotton. While LPO Davies was on the phone with CHASE Bank U S A. security unit he observed the 2 subjects purchase 2 SEARS \$500.00 dollars gift cards from an automated machine located in the store. The gift cards, item/sku #7602300, were purchased using the credit card issued to Deanna Cotton. The automated gift card machine issued the 2 gift cards total value of \$1,000.00 dollars. At this time LPO Davies approached the 2 subjects and asked them about the credit card. Both subjects went to SEARS Loss Prevention Office with LPO Davies. When I arrived at the SEARS Loss Prevention Office I asked both subjects if they had any form of identification. The female subject presented a South Carolina class D provisional license, license # 2900288, with the name of Deanna Cotton residing at 2835 Byrd Avenue, Columbia S C 29030 and a date of birth of 04-24-78 issued on 11-23-05. The license lacked the colored border that is on the upper portion of a South Carolina license. The printing on the back of the license was on a slight angle to the card and was not level. Again I asked the female subject for her correct name and she insisted that she was Deanna Cotton. At this time I used a phone at the SEARS Loss Prevention Office and contacted Officer Davis, the desk officer at precinct 2, and asked for her to do a browse of the name

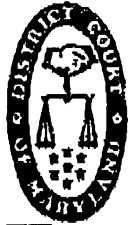

Deanna Cotton, date of birth 4-24-78. At this time the female subject stated that her middle name was Marie. Officer Davis advised that a browse came back for a Deanna Susan Cotton, date of birth 10-03-56, a white female. The name given by CHASE Bank U S A. as the holder of the card was Deanna Susan Cotton, a white female. Again I asked the female subject for her name and she stated that the name she gave me was false and that her real name was Ellen Marie Calhoun, date of birth 04-24-78, with no fixed address. At this time the male subject stated that she should be quiet and that he had made arrangements for her to get the false driver's license. The male subject then stated that he had gotten the credit card form a third party. The male subject stated that his name was Mark Young, no middle name, date of birth 03-22-50, with no fixed address. Subject Young stated that he did not have any identification with him. Subject Young was identified by a match of his MVA records. At this time I called Deanna Cotton about her credit card. Ms. Cotton stated to this Officer that she had not given any one permission to use her credit card. Ms. Cotton advised that she had been informed by CHASE Bank U S A. of a purchase of over \$2,000.00 dollars involving her credit card on March 19, 2006 at SEARS. Ms. Cotton stated that she had not made a purchase at SEARS on that day. LPO Davies checked store records and found that on Sunday, March 19, 2006 at 12:45 p.m. a 37 inch LCD widescreen television, item/sku # 7115500, valued at \$2299.88, had been purchased using Ms Cotton's credit card. At this time both subjects were placed under arrest and transported to precinct 2 for processing. Upon returning to precinct 2 I spoke with Ms. Cotton regarding her credit card. Ms. Cotton stated that recently she had been issued a new credit card from CHASE Bank U S A. and she thought she had destroyed her old credit card. While at precinct 2 both subjects, Ellen Marie Calhoun and Mark Young, were read their rights per Miranda by this Officer. I asked Subject Calhoun if she wanted to discuss the incident with the credit card. Subject Calhoun stated that she has used heroin for approximately 8

years with a daily usage of 4 times a day. Subject Calhoun stated that they had purchased a widescreen television on March 19, 2006 using the credit card. I asked Subject Calhoun what did they do with the television since they were homeless and she stated that she did not know what happened to the television. Subject Calhoun stated that Subject Young did something with the television but she would not say. At this time Subject Calhoun stated that she just wanted to get some help for her drug habit and was starting to experience withdraw. The interview was stopped at this time I asked Subject Young if I could ask him a few questions regarding the credit card Subject Young stated that he did not want to discuss the credit card without talking to counsel first. At this time I advised Subject Young that I would not ask him any questions.

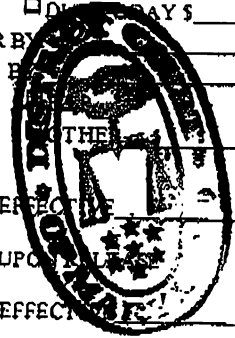

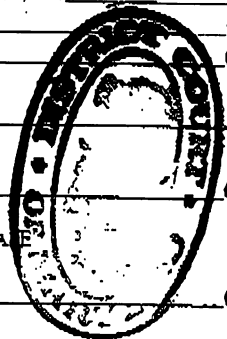

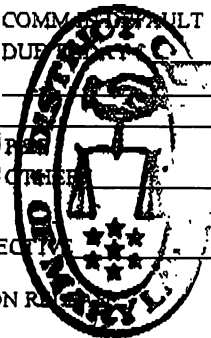
