Sheaffer's Store is significant as an example of the type of commercial structure which served St. Mary's County's villages as both vendors of general merchandise and sites of social gathering throughout much of the twentieth century. The bar on the west side of the store, named "Chief's Bar" for the current owner, was once an active tavern frequented by baseball teams who competed in the baseball diamond behind the store. Located next to a former gas station and a once popular dance pavilion, this building is the only structure which still serves a commercial function in the Tall Timbers community.

Built in 1927 by Charles and Ruby Bailey, "Bailey's Store" operated until 1944 when the property was sold to the Garner Brothers. The Sheaffers purchased the store in 1964 and sold it to William John Dent, a retired Navy chief, in 1978. Although Sheaffer's Store must now compete with larger chain grocery stores, many of the Tall Timbers and Piney Point residents continue to shop for vegetables, meats, and staples here.

Sheaffer's Store is located on the west side of Tall Timbers Road near the Piney Point Elementary School. Attached to the south side of the store's main block is the Tall Timbers Post Office. The store lot is bounded on the south by a large, two-story, masonry building, once a gas station and garage, and on the north by a one-story brick dwelling house. Behind the store stands a baseball field known as the "Bobby Thomas Memorial Baseball Park." The store faces east with its gable roof oriented on a north/south axis.

Built in 1927, the main block of Sheaffer's Store is a one-story, frame building. It is sheathed with weatherboard and roofed with asphalt shingles. A series of one-story additions extend outwards from the main block of the building on the north, south, and west elevations.

The east (main) elevation is pierced by two six-over-six sash windows and a modern entrance door. A porch with a cement pad floor extends across the front of this elevation. The porch roof, supported by square posts, shelters a series of vending machines. North of the entrance door, a shed roof addition which once housed a barber shop projects to the east. The barber shop is accessible by means of a four-light-over-three-panel door which opens out from the store's porch. To the north of the main block is a one-story addition which served as the original post office. The old post office addition is pierced by a four-light-over-three-panel door and a six-over-six sash window. South of the store's porch is a shed roof cinderblock addition which projects to the east. This addition was originally built for the storage of ice and refrigerated goods. The addition is pierced by a door on the north end which opens out from the store's porch and by a window on the east elevation. The current Tall Timbers Post Office is located in a modern extension of the ice house.

The south elevation consists of the gable end of the cinderblock post office section pierced by one one-over-one sash window on the first floor. Stepped back from the post office is the gable end of the store building. The store is pierced by a pair of six-light-over-three-panel doors sheltered by a gable roof portico. This entrance to the store was used for deliveries. The doors are flanked by one one-light window on either side. Stepped back from the store is the bar wing. The bar is pierced by an entrance door flanked on either side by diamond shaped windows. A shed roof addition extends from west wall of the bar wing.

The west elevation of the post office wing is blind. The west side of the store's main block is pierced by two three-light windows. The gable end of the bar's shed roof addition is pierced by three diamond paned windows. Two shed roof additions exten

Sheaffer's Store is significant as an example of the type of commercial structure which served St. Mary's County's villages as both vendors of general merchandise and sites of social gathering throughout much of the twentieth century. Located next to a former gas station and a dance pavilion, this building is the only structure which still serves a commercial function in the Tall Timbers community.

Built in 1927 by Charles and Ruby Bailey, "Bailey's Store" operated until 1944 when the property was sold to the Garner Brothers. This sale included the transfer of many of the store's fixtures, including everything from meat grinders to the booths in the tavern. The Baileys then moved next door and opened a garage and gas station in a two-story, masonry building which stands vacant today.

In 1964, the Garners sold the store to John and Grace Sheaffer. During the 1950s and 1960s, the store sponsored a baseball team which played in the field behind the structure. These games attracted large crowds. Opposing teams would come from as far away as Charles County to compete with the Garner/Sheaffer players. The baseball field is now owned by the St. Mary's County Department of Parks and Recreation and is used infrequently.

William John Dent, a retired Navy chief, purchased the store in 1978. The bar located on the west side of the store is now known as "Chief's Bar." Although Sheaffer's Store must now compete with larger chain grocery stores, many of the Tall Timbers and Piney Point residents continue to shop for vegetables, meats, and staples here.

7.1 Description

to the north of the bar.

The north elevation consists of a shed roof addition which extends from the west side of the store complex to the north gable end of the main block. A six-over-six sash window, four-light-over-three-panel door, an eight light window, and a five-panel door pierce this wing.

The interior of the store is finished with wood floors and a metal ceiling. The store is fitted with shelves and large coolers, and carries a stock of general goods. Access to the ice house was originally possible by means of a door on the south wall of the store. The bar is accessible from the interior of the store by means of a door on the west wall. Originally fitted with booths, a wet bar is located in the northwest corner of the room. A pool table, a trophy case, and some chairs and tables are also located in the bar area.

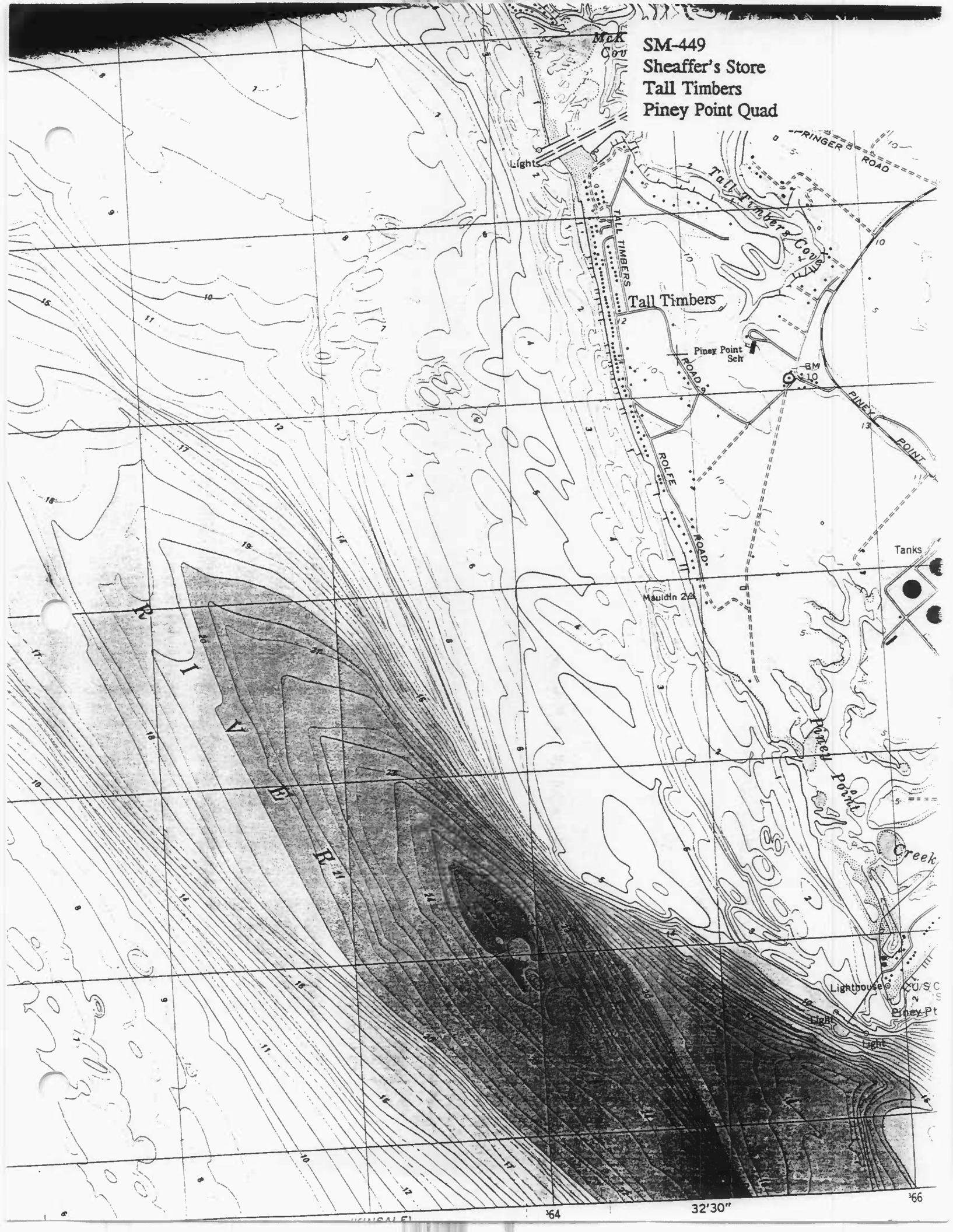
