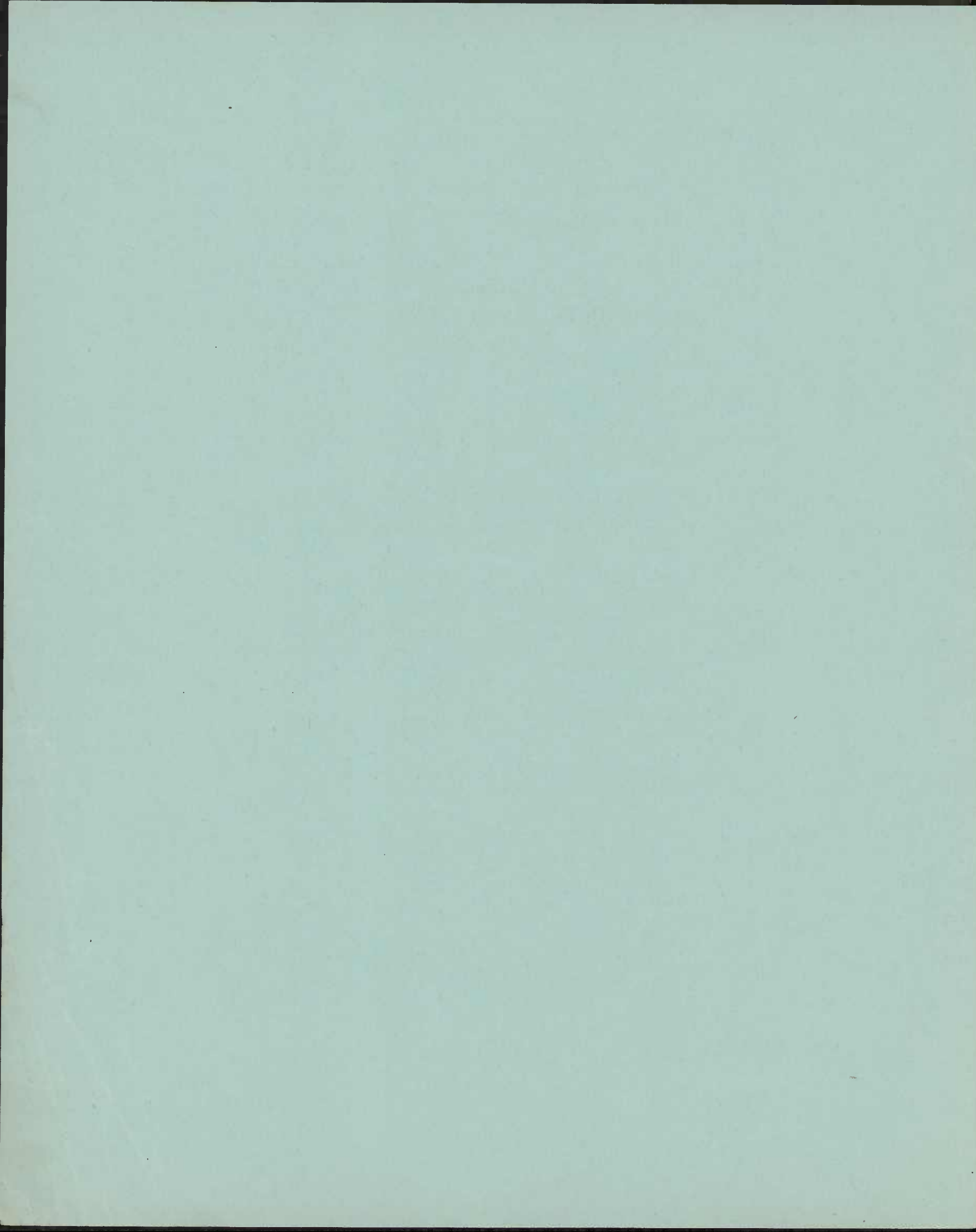

JOINT RESOLUTION

A Joint Resolution of the General Assembly of the State of Maryland ratifying the amendment to the Constitution of the United States of America proposed by Congress to the Legislatures of the several States.

1 WHEREAS, The Sixty-sixth Congress of the United States of
2 America has in due form as prescribed by the Constitution of
3 the United States passed the following Joint Resolution pro-
4 posing an amendment to the Constitution of the United States,
5 as follows, to wit:

6 *Resolved by the Senate and House of Representatives of the*
7 *United States of America in Congress Assembled (two-thirds*
8 *of each House concurring therein), That the following Article*
9 *is proposed as an amendment to the Constitution which shall*
10 *be valid to all intents and purposes as part of the Constitu-*
11 *tion when ratified by the legislatures of three-fourths of the*
12 *several States*

ARTICLE

13 The right of citizens of the United States to vote shall not
14 be denied or abridged by the United States or by any State
15 on account of sex.

16 Congress shall have power to enforce this Article by ap-
17 propriate legislation.

18 AND WHEREAS, Said proposed amendment has been sub-
19 mitted to the State of Maryland as one of the several States
20 of the United States of America, as required by the provis-
21 ions of the Constitution of the said United States, therefore,
22 be it

23 *Resolved, by the General Assembly of the State of Mary-*
24 *land;*

1 SECTION 1. That the said proposed amendment to the Con-
2 stitution of the United States of America be, and the same is,
3 hereby ratified by the Legislature of the State of Maryland.
