

At the request of Richard Whitworth the following Report of himself and family was recorded the 13th November 1819. to wit: To Upton Beall Esq^r Clerk of Montgomery County Court, The Report of Richard Whitworth respectfully sheweth, that the said Richard Whitworth together with his family consisting of his wife three sons and two daughters arrived at the port of Baltimore in the United States on the fifteenth day of January last past, and that he sailed from the port of Liverpool in the Kingdom of Great Britain from whence he migrated, that the said Richard Whitworth is of English extraction was born in England and is under allegiance to George the Third King of Great Britain and that he is now of the age of forty one years that his wife is an English woman by birth and residence as are also his children, The names of his children are as follows, Samuel, Richard & Smith the sons, and Sarah and Eliza the daughters, the eldest son is sixteen years old, the second ten and the third seven, the eldest daughter five and the youngest three years old, The said Richard Whitworth requests that this his report be registered as by the act of Congress passed on the 14th of April 1802 entitled An Act to establish a uniform rule of naturalization and to repeal the acts heretofore passed on that subject directs. Witness his hand this eighth day of November in the year of our Lord one thousand eight hundred and nineteen

At the request of David Newlin the following Bill of Sale was recorded the 15th day of November 1819. to wit: Know all men by these presents that I Cesar Williams (Blackman) of Montgomery County in the State of Maryland for and in consideration of the sum of one hundred dollars Current Money to me in hand paid by David Newlin of the County and State aforesaid at or before the sealing and delivery hereof the receipt whereof I do hereby acknowledge have granted bargained and sold and by these presents do grant bargain and sell unto David Newlin his executors Administrators and assigns one black Horse and one Bay Horse, one white Cow one Waggon and yeers a quantity of tobacco now hanging up in the House all my Household and Kitchen furniture consisting of the following articles (viz) one chest, one table, two Dutch ovens and one Iron pot, one saddle, all which property is now in my possession to have and to hold the same described property above bargained and sold to the said David Newlin his executors administrators and assigns forever to his and their only proper use and benefit, and I the said Cesar Williams for myself my executors and Administrators shall and will warrant and for ever defend by these presents to the said David Newlin his executors administrators and assigns the said described property against me my executors and Administrators and against all and every person or persons whatsoever claiming the same or any part thereof. In testimony whereof I have herunto set my hand and affixed my seal the 9th day of November 1819.
